Online purchases must include copy of the online purchase invoice and the installation invoice from authorized Goodyear Retailer. Work orders not accepted. Allow 6 to 8 weeks for Goodyear Mastercard® Prepaid Card/Virtual Card delivery.

Please choose which method of compensation you would like to receive. A physical card will be mailed in 10-20 business days upon successful rebate submission. A virtual card will be sent to your email within 7-10 business days after successful rebate submission.

Choose Virtual Card to have the rebate payment sent to you by email, and access funds quickly for online shopping. Choose Physical Card to have the rebate payment sent to you by ground USPS mail and to use the card for both in-store and online.
